The learned counsel for the Delhi Waqf Board states that there would be no violation of the orders passed by this Court. Consequently, the *status quo ante* as



on 27.05.2015, on which date the first *status quo* order was passed, shall be restored. The learned counsel appearing for the SDM (Saket) submits that the demarcation points have been identified and only the maps have to be prepared with regard to demarcation. She submits that the demarcation report shall be placed before this Court on or before the next date of hearing.

The Delhi Waqf Board shall file a further affidavit in terms of the order dated 01.02.2017 as also to indicate steps taken by them pursuant to the statement made today.

The learned counsel for the South Delhi Municipal Corporation shall also file a report, as directed on 01.02.2017, positively before the next date of hearing.

Mr Pant, the learned counsel appearing for the DDA, also states that the status report with regard to further progress, insofar as the drain running through the park is concerned, shall be filed before the next date of hearing.
