- 1. Mr. Khan points out, at the outset, that notice, in para 17 of the order dated 4 December 2023, was accepted on behalf of Ms. Sanya Choudhary on behalf of Defendant 9 and that notice would have to be separately issued to Defendants 7 and 19.

- **4.** On the last date of hearing, Mr. Wadhwa, learned Senior Counsel for GoDaddy.Com sought time to take instructions on this application. Today, he submits that he will file a reply to this application.
- **5.** Accordingly, issue notice. Notice is accepted, on behalf of Defendant 9 by Ms. Sanya Choudhary.
- **6.** Notice has already been directed to be issued to Defendants 7 and 19.
- 7. Let reply to this application, if any, be filed within four weeks with advance copy to learned Counsel for the applicant/plaintiff who may file rejoinder thereto, if any, within four weeks thereof.
- 8. Mr. Khan drew the attention of the Court to the fact that, though Defendant 9 had contended that the name jockeyshops.com stood registered with name Snapper LLC w.e.f. 25 October 2023, as per the "WHOIS" data available on the internet, the same domain name was being offered for sale by Defendant 9 on 6 December 2023 and even as on date.
- **9.** Mr. Wadhwa responds by submitting that Defendant 9 was not

offering the domain name jockeyshops.com for registration, but was only facilitating re-sale of the said domain name to another registrant which is an activity which is permissible as per the existing law and guidelines.

- **10.** He submits that it is not merely GoDaddy but also registrars who are similarly offering the domain name jockeyshops.com for reselling to other registrants.
- **11.** He is directed to place this stand in the reply filed to this application.
- **12.** Re-notify on 6 February 2024.
