3. This is a petition filed by jhuggi dwellers, who claim to be part of JJ Cluster, Janta Camp Railway Nursery behind Pragati Maidan. This Court had considered W.P.(C) 1654/2023 titled Jayanti Devi v. Govt of NCT of

Delhi & Ors. in respect of Janta Camp, Mathura Road, near Bhairon Marg. Since the said jhuggi cluster was not a notified cluster, no relief was granted in favour of the Petitioner and the petition was dismissed vide order dated 10th February, 2023 passed by this Court.

- 4. Today, ld. Counsel for the Petitioners submits that the cluster called JJ Cluster, Janta Camp Railway Nursery behind Pragati Maidan is a notified JJ Cluster bearing no. Item No.10 Code 10.
- 5. In order to ensure that the said clusters are properly identified, Mr. Chauhan, ld. Counsel for the DUSIB shall place on record the map of the notified JJ cluster so as to properly demarcate the said cluster.
- 6. Mr. Harish Vaidyanathan, ld. CGSC shall seek instructions from the Ministry of Railways in respect of the said JJ cluster.
